- A copy of the issued RRC permit for each well.

THE CITY'S NOTICE WILL SPECIFY THE DOCUMENTS OR OTHER INFORMATION NECESSARY FOR THE APPLICATION. IN ADDITION, THE CITY WILL INDICATE THE DATE THE APPLICATION WILL EXPIRE IF THE NECESSARY DOCUMENTS OR OTHER INFORMATION IS NOT PROVIDED. THE EXPIRATION DATE WILL BE ON OR AFTER THE FORTY-FIFTH (45TH) DAY AFTER THE DATE THE APPLICATION IS FILED.
