



PERMISSION TO REMOVE GRAFFITI

I hereby GIVE permission to the City of Denton and the City's employees, officers, contractors, and volunteers to enter said property at their convenience for the purposes of inspecting and abating graffiti located on exterior surfaces of the property. I understand that only the graffiti and the area immediately surrounding the graffiti is to be painted or cleaned. I agree that neither the City nor the City's designee(s) is required to conceal or remove the graffiti to my satisfaction, i.e. exact color matches are not possible. If the owner wants a closer paint match, they may provide paint in the amount needed as requested by the contractor. I hereby release and hold harmless the City, its employees, officers, agents, and volunteers from and against any and all liability, claims, suits, demands, or causes of action which may arise due to any loss or damage to personal property or personal injury resulting from the graffiti abatement work on my property. The permission granted herein to enter the above described property and to abate graffiti shall remain in effect until (a) written or verbal notice is provided to the Community Improvement Services revoking permission or until (b) the ownership of the property changes. IF PERMISSION IS BEING GIVEN FOR THE CITY TO ABATE GRAFFITI AT A RENTAL PROPERTY, PLEASE INFORM THE TENANT. IF THE TENANT DENIES THE CITY'S CONTRACTOR ACCESS TO THE PROPERTY, THEN THE OWNER WILL BE RESPONSIBLE FOR REMOVING THE GRAFFITI.

I hereby GIVE permission to the City of Denton and the City's employees, officers, contractors, and volunteers to utilize the onsite water source, if necessary, to abate the violations on this property (in the event a power washer is needed, for example).

I hereby REFUSE permission to the City of Denton and the City's employees, officers, contractors, and volunteers to enter said property at their convenience for the purposes of inspecting and abating graffiti located on the property.

I choose to GIVE permission to the City of Denton as stated above, however, I wish to give notice now that my permission is revoked effective ____/____/____. I understand that by revoking permission I will become responsible for removing all graffiti on the property from this date forward.
